Recall Description

On 1st March 2018, the Australian Government initiated a mandatory recall of certain vehicles with Takata passenger airbag modules, to be completed by 31st December 2020. The mandatory recall applies to all vehicles installed with a passenger airbag module made by Takata that contains either phase stabilized ammonium nitrate without desiccant or phase stabilized ammonium nitrate with calcium sulphate desiccant.

Safety risk description

As the driver airbag module ages, a combination of high temperatures and humidity can affect it, and if the vehicle is involved in a collision, the driver airbag module can deploy with excessive force. This will cause sharp metal fragments to shoot out and KILL or SERIOUSLY INJURE people in the vehicle.

Repair Description

Owners will be notified and instructed to take their vehicle to a Jaguar authorised repairer who will fit replacement passenger airbag. There will be no charge to owners for this repair.

Status

Completed. This vehicle has been part of a recall but is no longer effected.
