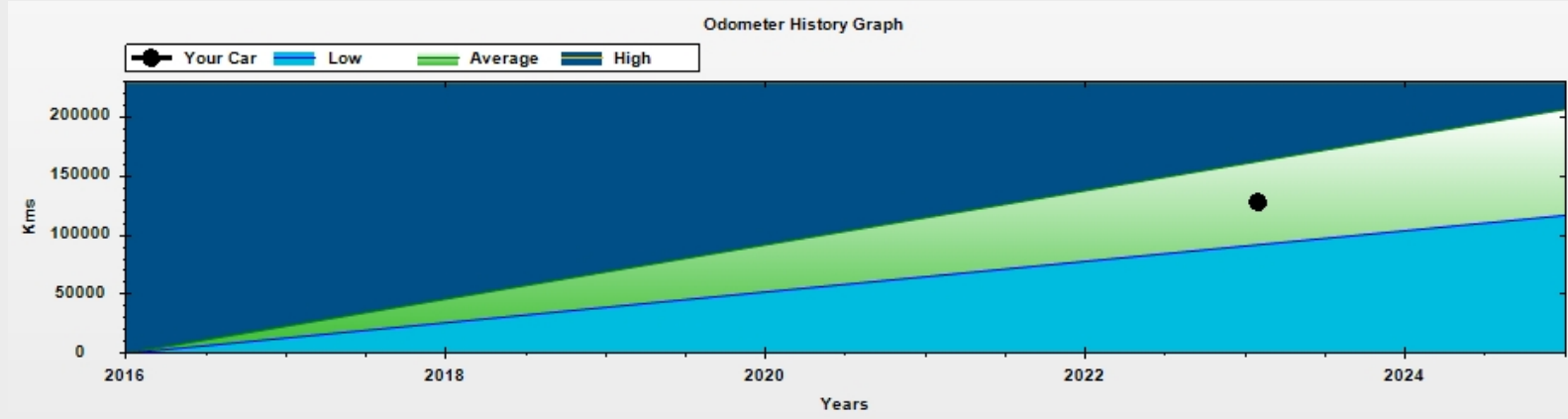

The score is a star rating, between 1 to 5 stars. The higher scores are awarded more stars. |
| Body | A vehicle's body type. |
| Cylinders/Rotors | Engine cylinder configuration. |
